## Membership Application Page:



The IMA Membership applications are accepted online. To begin the process, an applicant must create a login ID and password for this website. Click on the "Register" button above. If you have already registered, then click on "Login" button above to complete the application.

## Application Process:

1. All components of the application must be complete. An incomplete application will not be accepted/processed. We are unable to process an incomplete application.
2. If you are unable to complete the application in one sitting, log back in to continue where you left off.
3. The application for A.I.M.A. and M.I.M.A. consists of 2 parts, A and B. Part A contains the applicant contact information and academic information. Part B consists of the applicant related work history.
4. Upon completion of the application, the identified employer/supervisor will be notified to review Part B of the application (Part A is not accessible by the employer/supervisor). Note: Candidates who are self-employed may use an Accredited Professional: either an M.I.M.A. member or LSUC member as reference in completing Part B.
5. Upon completion of Step 4, the IMA will receive the application. Once the application has been processed and approved by the IMA Board of Directors, the member will be notified.

## IMA Membership Categories:

### Affiliate Membership:

**Definition of "Affiliate" Membership:** "Affiliate Membership shall be granted by the Board of Directors to a person or Corporation engaged in the assessment profession or a related assessment function who does not otherwise qualify under any other class of membership" as per IMA By-Law 1.

**Affiliate Membership Fee:** \$159 plus HST (new applicant membership fees are prorated).

### A.I.M.A. Membership:

#### Definition of "A.I.M.A." (Associate) Membership:

"Associate Membership shall be granted by the Board of Directors to a person who has successfully completed an Education Course approved from time to time by the Board of Directors". An Associate Member shall be entitled to use the designation "A.I.M.A." after his or her name.

**A.I.M.A. Membership Fee:** \$264 plus HST

**SPECIAL NOTE:** New applicants who meet the academic requirements for Associate (A.I.M.A.) status are eligible for a refund of membership fees for the 1st year on condition they register and pay for an IMA course leading to the Accredited (M.I.M.A.) Designation within the same year.

### M.I.M.A. Membership:

#### Definition of M.I.M.A. "Accredited" Membership:

"Accredited Membership shall be granted by the Board of Directors to a person who:

1. has qualified for Associate Membership in the Institute; and
2. has successfully completed the accreditation programs prescribed from time to time by the Board of Directors", as per By-Law 1.

An Accredited Member shall be entitled to use the designation "M.I.M.A." after his or her name.
